## CleanTech Alliance Membership Terms and Conditions

### Annual Membership Contract

- Annual Membership Contract: The SIC CleanTech Alliance membership operates on an annual contract basis. The membership term will commence from the date of activation and remain valid for one year, in accordance with the terms hereof.
- Annual Membership fees: USD 20,000 (approximately AED 73,000) per member.
- Automatic Renewal: Subject to payment of the renewal fee, the membership shall automatically renew for a subsequent year(s) upon the expiration of the initial term, unless either party provides written notice of cancellation at least 30 days before the renewal date.
- Cancellation: Membership shall be automatically renewed unless cancelled at the end of the term by a written notice to SIC prior to the 30-day cancellation window. If a cancellation notice is not received by this deadline, the membership will automatically renew for another year, and the corresponding membership fees shall become payable.
- Termination for Non-Payment: If membership fees remain unpaid by 30 days of the renewal date, SIC reserves the right to suspend or terminate membership without liability.

### 1. Showcasing Innovation and Dedicated Exhibition Space

- Event Participation: Members are invited to showcase their products or services at SIC events and flagship programs such as the Cleantech Innovators Program. These events provide opportunities for engagement with potential investors, clients, and partners.
- Exhibition Space: Members are entitled to one dedicated showcasing space, typically 2x2 sqm. in the SIC exhibition area for one full month per year. The showcasing content, material and relevance to be reviewed by the SIC and accommodated as per exhibit availability and/or other events happening at the SIC.
- Contract for Space: The use of exhibition space requires completion of the exhibition space application, confirmation, and full payment. All measurements on floor plans are approximate, and SIC reserves the right to modify the floor plan as deemed necessary for the benefit of the event and exhibitors.
- Space Allocation & Modifications: Space allocation will be communicated through formal notification. SIC reserves the right to modify the floor plan and make equitable adjustments as required.
- Installation & Dismantling of Exhibits: All exhibits must be fully installed and ready for inspection the day before the event or first show day. Dismantling may only take place after the close of the event. Exhibitors must adhere to instructions as per SIC's event schedule.
- Storage: Exhibiting members will not be allowed to store boxes or packing crates in or behind their exhibit booths. All crates should be labeled for storage, and any unlabelled materials will be removed or discarded by SIC, without need for any notice or warning.

### 2. Event Invitations & Recognition

- DEWA Event Participation: Two key representatives from member organizations will be invited to participate in high-profile DEWA event opening ceremonies. Access to flagship events (WETEX, WGES, Cleantech Innovators Program).
- Speaking & Presentation Opportunities: Invitations may be extended for members to participate in panels, presentations, and discussions at flagship events like SIC events and programs. Speaking opportunities will be based on the relevance of the member's products or services to the event's goals.
- Social Media & Public Acknowledgment: New members will be welcomed on SIC's social media platforms, and all members will be recognized at the end of the year in SIC's communications.
- Content & Publications: Members may be highlighted in SIC's annual report and other publications, which will outline their contributions and achievements over the year.

### 3. Networking & Knowledge Sharing

- Networking Events: Members will be invited to an annual networking event that fosters collaboration and connections within the SIC community.
- Knowledge Transfer: SIC facilitates the exchange of expertise and insights among members through various events, webinars, and knowledge-sharing sessions.
- Hackathon Judges: SIC invites members to nominate representatives and experts to serve as judges for the annual hackathon, ensuring high standards of evaluation and fostering further networking opportunities.

### 4. Visibility & Branding Opportunities

- Logo Placement: Members' logos will be prominently displayed at DEWA's discretion on the SIC website, event materials, and media platforms as appropriate. All logos must be submitted in the correct format and size and adhere to SIC and DEWA branding guidelines.
- Annual Report & Media: Members will be featured in SIC's annual report, showcasing their successes, contributions, and milestones.

### 5. Exclusive Event Access & Presentation Opportunities

- Front Row Seating & Presentations: Members are offered exclusive front-row seating at events showcasing innovative solutions, providing direct access to cutting-edge industry advancements.
- Roadshow & Event Participation: Members will be invited to present their initiatives at the annual SIC roadshow and participate in flagship events.
- These opportunities will be subject to event guidelines and approval.

### 6. Facility Use & Discounts

- Auditorium & Venue Rentals: Members are entitled to one free auditorium rental per year, and a 50% discount for a second venue rental within the same year. Additional services not limited to catering and equipment rental may incur extra costs.

### 7. Employee Wellness & Support

- Wellness Program: Members have access to SIC's employee wellness program, which includes online mental health support and other well-being initiatives.

### 8. Exhibit Tickets & Discounted Group Rates

- Free Exhibit Tickets: Each member receives 10 complimentary SIC exhibition tickets per year.
- Discounted Group Rates: Members can purchase additional tickets as per the approved travel and tourism partner rates which will be shared upon request.

### 9. Celebrations & Community Engagement

- SIC Celebrations: Members will be invited to participate in SIC's annual celebrations to recognize collective achievements and foster a strong sense of community among members.

## Appendix - Exhibition Specific Terms

### Installation & Dismantling

- Setup: All exhibits must be fully installed and ready for inspection the day before the event or first show day. Dismantling may only begin after the event officially ends, and no materials may be removed before this time.
- Removal: All exhibits and fixtures shall be removed without causing any damage to the SIC venue. If the Member fails to remove promptly, SIC reserves the right to remove at member's cost and without any liability to SIC.

### Exhibitor Conduct

- Subletting and Sharing: No exhibitor shall assign or sublet any part of their space to third parties without SIC's written approval. Only the registered exhibitor may display their materials in the rented space.
- Booth Regulations: Exhibitors must ensure that their booth complies with SIC's specifications and does not obstruct aisles or neighboring booths. Demonstrations must be confined to the exhibitor's designated area.

### Liability & Insurance

- Exhibitor Insurance: Exhibitors are required to carry insurance covering for their exhibit materials and public liability for potential damage or injury. SIC is not liable for any loss or damage caused to or arising out of exhibitor materials during the event.

### Compliance with Safety Regulations

- Safety Compliance: Exhibitors must comply with all local regulations concerning health, fire safety, and public safety as well as SIC regulations. SIC will not be responsible for ensuring compliance but reserves the right to remove non-compliant exhibits at the exhibitor's cost.

### Data Confidentiality and Protection of DEWA Information

#### Confidential Information

- During the course of your membership with SIC and participation in SIC activities, you may be provided with or have access to confidential or proprietary information belonging to DEWA, SIC, or other members. Confidential Information may include, but is not limited to, business plans, technical data, research, and development information, marketing strategies, financial data, and other information not publicly disclosed.

#### Non-Disclosure Obligations

- Members agree to not disclose or use any Confidential Information except as necessary to perform the activities related to their membership benefits. Confidential Information must not be shared with third parties or used for any purpose other than that which it was intended for by DEWA or SIC.
- This non-disclosure obligation shall continue indefinitely, even after the expiration or termination of membership.
- DEWA's Standard NDA will be executed with member (appendix to this agreement)

#### Data Protection

- Members are responsible for complying with all relevant data protection laws and regulations, including the UAE's Data Protection Laws, when handling personal or sensitive data. Any data provided by DEWA or SIC must be kept secure and protected from unauthorized access, use, or disclosure.

#### Handling DEWA Information

- DEWA's proprietary or confidential information must be handled with care, ensuring that it is stored securely and only shared with authorized individuals. Members may not use DEWA information for personal gain or disclose it to third parties without DEWA's written consent.
- If a member is found in breach of this confidentiality obligation, SIC reserves the right to terminate the membership and take legal action if necessary to protect DEWA's rights and information.

#### Return or Destruction of Information

- Upon termination of the membership, or upon request by DEWA or SIC, members are required to return or securely destroy any Confidential Information, provided by DEWA or SIC.

#### General Terms

- Eligibility: Benefits are available to active members in good standing. Some benefits (e.g., exhibition space, event invitations) may be contingent on specific criteria or event relevance.
- Cancellation: Cancellation or reduction of space, if applicable, must be communicated in writing. A cancellation penalty may apply as per the specific event terms.
- Amendments: SIC reserves the right to modify or update these Terms and Conditions from time to time, during the term, and all amendments will be communicated to members.
- Governing Law: This Terms and Conditions are governed by the laws of the Emirate of Dubai, UAE.
